COMMODORE'S REPORT

A major focus this year has been resetting a sense of camaraderie, belonging and pride in our activities as a Club. This has been a terrific year bouncing back from the confines imposed during Covid. Revamped social events including Opening Day and the Appreciation and Presentation Nights have been well attended. The Foundation Lunch with footballer Max Gawn was a huge success. Providing sailing opportunities to Ukraine children seeking refuge from the war and reigniting the Victory Cup golf competition amongst other yacht clubs around the bay rounded out major social events during the season. Brownies Raffle on Friday nights together with the Club Draw attracts good numbers of people as well as helps raise funds for the Club.



Our Off the Beach fleet have had a busy year with the running of the State Opti Titles and hosting the Victorian School Team Sailing Championship. Many of our youth sailors have journeyed overseas competing very successfully in regattas.

Several new keel, sports and trailer boats have joined the register and with the addition of their crews have regularly competed in Club events and performed well in both Port Phillip Bay and offshore races. Thursday twilight racing regularly attracts 30 to 35 boats competing for the converted bottles of wine.

The need for flat water hampered our Sailability operations although the days that were suitable saw good numbers of sailors with the helpful support of volunteers. Our Sailability program is the strongest around the Bay and contributes significantly to the Club's operations.

Club events together with the Rocks operations means we regularly have over 250 to 300 people on site which has highlighted the need for us to upgrade our amenities and ensure we present a smarter built environment to members and visitors.

Membership has steadily grown to 926 people.

Our debt shadow is now more manageable we have been able to plan and undertake an extensive range of works. We are fortunate to have a large body of people who continue to provide their skills either in kind or well below commercial rates enabling us to execute projects very cost effectively.

In May 2022, the State Government announced Mornington's Schnappers Point precinct as an important recreational activity centre. Parks Victoria will "develop a Local Port Area Plan proposing improvements to meet community needs, balance and enhance existing uses and creating new, safer recreation and commercial opportunities." A sum of \$6.7m of which \$500,000 for studies has been "committed."

MYC has been invited to participate in focus groups. Parks are aiming to share concept designs for the replacement of Fisherman's Jetty including the creation of fairways for commercial traffic in September 2023. Our interpretation

at this point is that this is to enable a future ferry operation which we are supportive of providing berthing and parking issues are resolved.

The Council is trialling paid parking for non-shire residents from November 2023 together with time limit restrictions for all vehicles. Seventeen percent of our members including volunteers live outside the shire. At the time of writing, we have raised a number of issues with Council seeking further consideration to our operations as well as the activities of other users of the precinct.

The next few years promise to be interesting, challenging, and developmental. I am confident that the strength of the Club will endure, and all our activities will continue to make a valuable contribution to community wellbeing.

To our staff and the volunteer members of our Finance Committee, Training & Development Committee, Racing Committee and the TAG team, the General Committee thank you sincerely for your support.

REAR COMMODORE'S REPORT

"We started with an official opening and sail past and finished with a presentation night party, and in between got a full season of sailing"

Obviously it was wonderful to escape our Covid restrictions and commence the season on time.

This year we introduced a new race entry and scoring system called SailSys. This web based program was installed prior to the season start and with the superb help from the SailSys team and our own Stephen Bolton and Cam McKenzie we were up and running for race one. During this first season's operation some latitude has been given to those who have not got themselves up to speed on the software, but that time has passed and all skippers,crews and boat details will be mandatory for the coming season. To this end the NOR will reflect the requirements that members must meet and the assistance that will be given to members to achieve this. The importance of knowing who is out there on the race



track is vital from our safety standpoint and the SailSys system gives us this information very effectively, as long as our competitors are compliant. We look forward to your cooperation with entry and crew compliance. It's not hard and we are here to assist.

Again we thank our volunteers in race management both on and off the water and the members ashore who keep our equipment in good order. There are too many to name but I will highlight the wonderful input from Stephen Bardsley on shore, John Mills on water and Laurie White on equipment, each of whom run wonderful support teams.

The OTB team led by Ben Jones and Andrew Weber with admin support from Cam McKenzie have again provided an excellent Sunday program with great participation across our Opti, Laser and 420 fleets. Of course the parents who support their kids and young adults are the backbone of the OTB scene.

Training and development has also completed another fine year with Immi Weber and Will McKenzie providing great coaching opportunities to all categories of our Junior and Youth participants.

A good season this year weather wise with only a small number of races lost to poor conditions.

Top performers in Club based events for Keelboats and Trailables were Ian Smith (Blackjack), the Remedy syndicate (Remedy) and Tim Donnellan (Zippier).

In the OTB classes the top performers in Club based events were Jack Vermeer (Crackerjack), Josh Bacon (Sonic Dash) and Louis Coates (Optimist Prime).

TREASURER'S REPORT

This report is for the financial results of the Club for the year ended 31 March 2023

OVERVIEW

The **Net Reported Surplus** for the financial year was \$18K (prior year \$110K) and an **Operating Surplus** before Interest, Depreciation and Abnormal items of \$155K (prior year \$227K).

Closing **Cash Available** was \$177K (prior year \$415K)

Capital Expenditure was \$226K (prior year \$70K)

CBA Loans decreased \$91K to a closing balance of \$269K.



COMMENTS ON THE RESULTS

The club's closing **Cash Available** decreased year-on-year -\$238K reflecting a surge in **Capital Expenditure** and major **Repairs & Maintenance**. Notable capitalised expenditures included a renovation of the downstair area (\$140K), concreting the western side of the yard (\$50K) and the introduction of a FOB entry system (\$21K). Repairs and maintenance of \$132K was expensed (versus \$67K prior year), notably: jetty repairs, rescue boat repairs and back fence gate replacement.

The **Operating Surplus** before Interest, Depreciation and Abnormal items was \$155K (versus \$227K prior year). This represents the club's operating cash generation capacity before repayment of loans, expenditure on capital expenditure (depreciation) and other non-operating items. Notable year-on-year changes were an increase in the club's Cleaning expense from \$21K to \$45K (change in contractor and expanded floor area) and an increase in salaries expense from \$81K to \$105K (return to normal staffing levels after a maternity leave).

Member Subscriptions income improved by \$24K or +11% over prior to \$242K, which includes a general 3% increase in annual subscriptions by category. Non-Sailing membership subscriptions were 28% of this total at \$67K.

Rocks Rent income was \$261K (versus \$256K prior year).

Bank Loan balance was \$269K (versus \$359K prior). The CBA loan is planned to be fully repaid by October 2025.

FORWARD LOOKING

The Finance Committee estimates that the club generates \$120K cash each year (after loan repayments) that is then available to be spent on major repairs and capital expenditure projects.

The enclosure of the back deck, toilet repositioning and member's kitchen move is expected to cost \$85-100K. Additionally, the sea-facing fence and concrete area is expected to be replaced at a cost of ~\$80K. The latter expenditure may require some additional funding sources to support this project, or the project may be deferred until the following winter as funds become available.

The General Committee has authorised a general 5% increase for member subscriptions (except Social membership), slipping and storage fees.

SUBSEQUENT EVENTS POST BALANCE DATE

There have been no events that have significantly affected the club's financial position post 31 March 2023.

As Treasurer, I chair the club's Finance Committee consisting of Stuart Gooley, Mark Nicholson, Michael White, Joanne McKenzie, and David Coloretti. I thank the Finance committee for the valuable insights they have given me with their many years of accumulated experience at the club. The Commodore's report was tabled in the Annual Report which was circulated by email to all members. Greg read a brief resume of the report, mentioning the club's enormous progress over the last year with thanks to the fantastic work of the current board and sub-committee's, and that he is proud to have sat in the chair for the previous 3 years. He then gave his ongoing support to the new board.

An update was given on the current projects, expressing further yard improvements and appreciation was given to Laurie and the TAG team.

Andrew also spoke about the funds that the State Government are allocating to Mornington Harbour, including the enormous benefits of re-building Fisherman's Jetty and that the clubs Future Directions Sub-Committee will endeavour to work with Parks and the Council to ensure that the funds are spent wisely from the club's perspective.

Andrew concluded the meeting with thanks to Sailability and a welcome to Ben Jones for joining the board.



Annual Report for Year Ended 30th June 2023

The Trustee of the Foundation is the Mornington Yacht Club with the operations of the Foundation being governed by a Trust Deed under which the day to day management is delegated to a Board. At 30 June 2023 and for the year then ended the Board comprised:

For the year the Foundation receipts totalled \$29,907 due largely to the very successful Business Lunch raising \$24,922 at which Max Gawn was the guest speaker. Thanks to everyone who contributed to the success of this event which raised over double the funds of the previous year.

Members of the Club were encouraged to make a contribution to the Foundation when paying their annual subscriptions and this raised nearly three thousand dollars. With close to 900 members a contribution of \$50 in this way could raise \$4,500 annually.

The Foundation continued to make grants to members in the Junior and Youth Assistance program totalling \$6,000 this year. We are fortunate in having a group of outstanding youth sailors who are participating in various programs being run by Australian Sailing to further develop their elite sailing skills.

The details of the grants were;

Sophie Jackson-\$3,000. Competing in the 470 mixed class in World Cup and World events in Europe.

James Jackson and Lily Ricardson \$2,000. mixed class 470 class competing in World Cup Regattas in Europe.

Leigh Harvey \$1,000 to compete in the 2023 Opti Australian Championships.

In addition Lachie Weber received a grant of \$2,000 contingent on his selection as an Australian representative in the World Laser Championships. Lachie has now qualified for this title event and his grant will be paid in the 2023-24 financial year..

As a condition of these awards the recipients have agreed to provide assistance to the Club in training or other activities.

It is not the intention of the Foundation to accumulate a corpus of funds and the balance of our funds at June 30 will be deployed to further the objectives of the Foundation in areas of sail training, Club infrastructure, rescue boats and Sailability. A number of projects are currently being considered by the Foundation Board.

Distributions by the Foundation since its establishment 7 years ago now total \$148,026. These distributions have been made in the following categories:

Sail training assets (pacer dinghies and optis)	\$69,594	47%
Club infrastructure (slipway)	31,245	21%
Junior & youth sailing assistance grants	27,304	18%
Rescue boat purchases (rhib)	12,782	9%
Sailability (sails)	7,101	5%

The Foundation is an approved gift recipient under the auspices of the Australian Sports Foundation established by the Government to encourage donations to sporting organisations by providing tax deductions to donors. In addition the Foundation can receive donations directly and raise funds through running functions.

We would like to thank members for their support during the year which has enabled funds to be raised to materially assist the Club in providing improved services and facilities for members.
